ESEA FLEXIBILITY WAIVER

Work has begun on the development of an ESEA Flexibility Waiver. The U.S. Department of Education will provide technical assistance as Nebraska moves forward with development of a draft waiver for the State Board to consider in February. Aprille Phillips, the state student achievement director, and Matt Heusman, a state research and data analyst, will oversee the writing of the draft waiver.

COMMISSIONER BLOMSTEDT'S EMPLOYMENT CONTRACT

The State Board of Education unanimously approved a three-year employment contract extension for Nebraska Education Commissioner Matt Blomstedt and raised his salary 5 percent. Board members commended Commissioner Blomstedt for his work on behalf of Nebraska students and for his leadership.
