Two courses (5 semester credit hours) are required for all candidates in teacher education. Both include instruction in individualized education program teams and also include field experiences. One course (3 semester credit hours) is required of all early childhood, elementary, and middle level candidates in ESL instruction methodology.

Our new special education program to be officially started in Fall, 2010 will include the same elements as those listed above. It will expand on this with coursework addressing multiple special needs areas - mild/moderate disabilities, learning disabilities, and behavior disorders. It will include instruction in American Sign Language, adaptive physical education, and assessment, evaluation, and IEPs.

All candidates seeking an endorsement in early childhood, special education, elementary, or middle level also complete a 3-hour course in Foreign Language Instruction to prepare them for working with students who do not have English as their first language. A 15-point Conceptual Framework is used for evaluation purposes. Self-evaluations, instructor evaluations, cooperating teacher evaluations, and university supervisor

evaluations are all coded to the Conceptual Framework. This information on all candidates is reviewed annually.
