- Understands the seven domains of early learning for children from birth through age 5.
- Understands how to implement active learning experiences for children around the seven domains of early learning.
- Have completed the Early Learning Guidelines domain training series or its equivalent.
- Have a history of working in an early childhood program that has a history of compliance with child care licensing regulations, NDE Rule 11 regulations, Head Start Performance Standards, or National Accreditation standards.
- Have at least 3-4 years of experience as a trainer.
