FINAL ORDER

This matter came before the State Board of Education ("State Board"), Lincoln, Nebraska, on June 27, 2023, upon the recommendation of the Nebraska Professional Practices Commission ("NPPC") that the public Nebraska teaching certificate of the Respondent, Carlene McCulloch, be suspended for a period of one year. The parties were notified of the State Board's consideration in this matter. Appearing before the State Board was Tamra L. Walz, General Counsel, on behalf of the Commissioner of Education. NPPC Clerk Kelly Muthersbaugh appeared and provided a summary of the NPPC's recommendation in this matter. The Respondent did not appear.

The record of the NPPC proceeding, containing the "Findings of Fact, Conclusions of Law, and Recommendation of the Commission," all of the pleadings, exhibits, and a written transcript of the NPPC hearing, was received by the State Board into evidence as "Exhibit 1." The Notice of Disposition and the certified mail return receipt were received into evidence as "Exhibit 2." Upon its independent review of the entire record, the State Board finds, concludes, and orders as follows:

1. The State Board has jurisdiction in this case pursuant to Neb. Rev. Stat. § 79-866(2) (2014);

2. The Petitioner is Matthew L. Blomstedt, Ph.D., Commissioner of Education, P.O. Box 94933, Lincoln, NE 68509-4933;

3. The Respondent is Carlene McCulloch, 1684 S. 152nd Street, Omaha, NE 68144;

4. The Respondent holds a public Nebraska Initial teaching certificate number 20220004928, endorsed in Middle Level/English–Language Arts 5-9, with an expiration date of August 31, 2027;

5. The Respondent was employed by the Millard Public Schools as a teacher beginning with the 2020-2021 school year;

6. Beginning on or about August 3, 2022, the Respondent did not adhere to the terms of her contract with Millard Public Schools for the 2022-2023 school year;

7. The Respondent has violated Neb. Rev. Stat. § 79-821 (2014), which states, in pertinent part: “Upon presentation of proof that any teacher . . . has, without just cause, violated or abrogated his or her contract with a school district in the state, the State Board of Education shall suspend the certificate of such teacher . . . for a period of not more than one calendar year after a hearing has been held at a time and place fixed by the board and of which notice has been given to the person whose certificate is sought to be suspended by either registered or certified mail at least ten days prior to the hearing.”; Neb. Rev. Stat. § 79-866(2) (2014), which states, in pertinent part: “The board may, for just cause, revoke or suspend any teacher’s or administrator’s certificate. Violation of the standards established pursuant to this section, commission of an immoral

act, or conviction of a felony under the laws of this state shall constitute just cause for the revocation or suspension of a teacher's or administrator's certificate by the board.”; Title 92, *Nebraska Administrative Code*, Chapter 27, Section 004.06C (effective date: November 12, 2003) (“the educator: Shall give prompt notice to the employer of any change in availability of service”); Section 005.02B2 (same effective date) (“Each teacher and special services provider shall: Adhere to and enforce written and dated administrative policy of the school which has been communicated to the teacher or special services provider”); and Section 007 (same effective date) (“Educators shall adhere fully to the terms of a contract or appointment.”);

8. By a preponderance of the evidence, just cause exists pursuant to Neb. Rev. Stat. § 79-866(2) (2014) to suspend the Respondent's certificate for a period of one year; and

9. The public Nebraska Initial teaching certificate of Carlene McCulloch, number 20220004928 endorsed in Middle Level/English–Language Arts 5-9, with an expiration date of August 31, 2027, shall be suspended for a period of one year from and after the date of this order.
