phenomenon: an unusual or significant fact or event In the last sentence of "A Highway of Water," the author claims the Panama Canal is a phenomenon. Analyze how the author support this claim throughout the passage. Write a well-organized response using specific evidence from the passage to support your answer.

Sample A

The author of "Highway of Water claims that the Panama Canal is a phenomenon. I think the author is correct because the canal is both unusual and significant. First the canal is unusual because it was a new route to connect New York and California. Before the canal was built the travelers had to cross the prairie land, sail and walk across Panama by foot, or sail all the way around the tip of South America. The canal was like crossing Panama but without having to walk. Second, the canal was significant because it was a huge project to complete. France tried to build the canal but their workers got sick and some even died. It also took lots of money. Because of all these problems France gave up and the United States had to take over. Third the canal was also significant because it used a system of locks so the ships could travel between the two oceans and each lock contained millions of gallons of water! Fourth, the canal is significant because so many ships use it, "approximately 14,000 ships make the 50 mile trip through the canal each year." That is a lot of ships that can now take a short cut and save a lot of time! In conclusion, the author was correct in calling the Panama Canal a phenomenon because it was both unusual and significant.

Sample A Annotation

Score: 3

This response demonstrates effective analysis of text, use of evidence, and writing skills. The response addresses all parts of the task by analyzing how the author supports the claim that the Panama Canal is a phenomenon. Specific, relevant evidence is integrated into the analysis. The response is focused on the idea that the canal was both unusual and significant. Clear use of paraphrasing and quoting is evident. Use of precise word choice and content specific vocabulary from the text is evident. Errors in conventions do not interfere with meaning.

Sample B

The author states the Panama Canal is a phenomenon that is an unusual or significant fact or event. It is a phenomenon because before it was built sailing by ship from ocean to ocean was a dangerous 15000 mile journey that took months. After it was built, the route was 8000 miles shorter. It saved time, money and even lives which is always significant. But building a canal was not easy. It started with failure but after a lot of work it ended in success.

Plans to build a canal started in 1850 when the United States and Great Britain planned to build a canal through the Central American Republic of Nicaragua. "The project didn't even make it beyond the planning stages". That is pretty unusual.

Next, in 1879 the French decided to build a canal in Panama which was only 50 miles wide at its narrowest part. They hired an experienced builder who had built the Suez Canal in Egypt but they experienced problems they were not able to overcome such as tropical diseases killing the majority of the workers, and temperatures as high as 130 degrees. The French ran out of money for the canal and in 1899 abandoned the project. All these details are very unusual!

Finally in November 1904 the United States began to finish the canal. It wasn't easy because before they started they needed to sign a treaty between the United States and Panama, "this deal was viewed as a major foreign policy achievement at the time". The United States learned from the problems the French had and found ways to "avoid the problems that caused France to abandon the project". Some of the things they did was keep the workers healthy by building hospitals and water and sewage systems. Their hard work all paid off on September 26, 1913 when an old tugboat went through the canal through a system of locks and gates, another huge significant achievement.

Overall, the Panama Canal is a phenomenon because it is unusual and significant. It created a new "highway of water" through Panama which is significant. It all took place through the extraordinary (unusual) efforts of many countries involved in the planning and building of the canal. It also was a major foreign policy achievement and it changed how ships travel forever! That is very significant!

Sample B Annotation

Score: 4

This response demonstrates exemplary analysis of text, use of evidence, and writing skills. The response addresses all parts of the task, thoroughly analyzing the author's claim that the Panama Canal is a phenomenon by thoroughly addressing the ideas from the text. The response provides relevant and accurate evidence to thoroughly support the idea that building the canal was an unusual and significant event. The response is well-focused and demonstrates an appropriate organizational pattern. The response demonstrates skillful use of paraphrases and quotes from the text. Precise word choices and content-specific vocabulary from the text are evident.

Score: 2

This response demonstrates partially effective analysis of text, use of evidence, and writing skills. The response partially addresses the task of analyzing how the author supports the claim that the Panama Canal is a phenomenon and provides a partial analysis of explicit ideas from the text. The response includes a partially effective introduction, body, and conclusion. The response demonstrates partially effective use of paraphrases and quotes. Errors in conventions may interfere with meaning.

Score: 1

This response demonstrates minimal analysis of text, use of evidence, and writing skills. The response minimally addresses the task, demonstrating a minimal understanding of the text and provides little evidence from the passage to support ideas. The response demonstrates minimal use of paraphrase or quotes. This brief response does not demonstrate evidence of effective writing skills.

Score: 2

This response demonstrates partially effective analysis of text, use of evidence, and writing skills. The response addresses some parts of the task and demonstrates a partial understanding of the text. The response partially analyzes text by addressing explicit ideas from the text. The response partially integrates evidence from the text by using some details, examples, and quotes. The evidence provided partially supports the claim that "the author clarifies that the panama canal is a phenomenon." The response is partially focused and includes a partially effective introduction and body and lacks a clear conclusion. Minimal use of paraphrasing and quotes is evident. Errors in conventions may interfere with meaning.

Sample F

The Panama Canal is important in many ways. Three ways are that it saves time, there are locks and gates, and the deal was viewed as a major foreign policy.

First, the Panama Canal saves a lot of time. If you want to get to California from New York and wanted to go on boat you would probably choose the Panama Canal instead of going around South America. I takes eight months to go around South America and it only takes three months to go through the Panama Canal. That is a five month difference and five months is a lot of time. Second, the Panama Canal has locks and gates. When boats and ships go through the canal they have to go through three sets of gates. Each gate hold millions of gallons of water. So when ships go through each gate water gets pumped either in or out of the gate so that the water level is even with the next one. What that does is raises or lowers the ships.

Lastly, the Panama Canal's deal was viewed as a major foriegn policy. The United States paid France \$40 million for the completed work and abandoned equipment. Then a treaty between the U.S. and Panama signed paying Panama \$10 million for a 10-mile wide strip of land. The treaty also guaranteed \$250,000 to Panama each year for the use of land and ensured its independence.

Sample F Annotation

Score: 3

This response demonstrates effective analysis of text, use of evidence, and writing skills. The response addresses the task and demonstrates understanding of the text by analyzing explicit and implicit ideas from the text. Specific evidence from the text is integrated through the use of details and examples. Relevant and accurate evidence from the text supports the claim that "the Panama Canal is important in many ways." The response is focused and includes a clear introduction, body, and conclusion. Partially effective use of paraphrases and quotes is evident. Errors in conventions do not interfere with meaning.

Sample G

Sample G Annotation

Score: 2

This response demonstrates partially effective analysis of text, use of evidence, and writing skills. The response addresses some parts of the task to demonstrate partial understanding of the text. This summary of the text partially addresses explicit and implicit ideas from the text. Some of the evidence provided from the text is not accurate. Evidence from the text is partially integrated into the analysis. The response is partially focused and includes a partially effective introduction/thesis, body, and conclusion. Partial evidence of an organizational pattern suited to the purpose is demonstrated as the response is a summary using details that relate to the prompt. Use of paraphrasing is evident. Precise word choice and vocabulary from the text are occasionally used. Some errors in conventions interfere with meaning.

Sample H

Sample H Annotation

Score: 1

This response demonstrates minimal analysis of text, use of evidence, and writing skills. This response addresses some parts of the task to demonstrate partial understanding of the text. The text is partially analyzed through addressing explicit and implicit ideas from the text. Little evidence is provided to support the claim that the Panama Canal is a phenomenon. Evidence from the text is minimally integrated through the use of very few examples, details, and quotes. The response is minimally focused and lacks an introduction/thesis. The body, conclusion, and transitions are partially effective. Minimal use of paraphrasing and quoting is evident. Use of precise word choice and vocabulary from the text is minimal. Errors in conventions do not interfere with meaning.
