## 1. Rule Status Updates - NDE Staff

• Rule 25 approved with effective date of 8/15/16.

#### 2. Rule 24 Endorsements - Pat Madsen, NDE

 Proposed School Counselor Endorsement – Donna Hoffman, NDE School Counseling Specialist

Discussion has continued regarding the transition of an individual with a Counseling Masters which is not inclusive of School Counselor preparation. An additional meeting was held in July for continuing discussion. The meeting included representatives from NE institutions with a School Counseling program, NCTE Executive Committee/NCTE, Ad Hoc members, and NDE staff. Their recommendations are reflected in the version presented to the Executive Committee the 8/26/16 meeting. The current proposed version would provide for a relatively easy transition to an Alternative Permit for the individual coming with a Counseling preparation without a school counselor specialization.

Executive Committee discussed options if the proposed endorsement revision does not receive NCTE Committee/Council support.

Action: Executive Committee consensus to move the current revision to full Council consideration, with the recommendation that NCTE meeting agenda be organized to facilitate adequate time for conversation among the entire Council.

 Proposed Work-Based Learning (WBL) (formerly Cooperative Education/Diversified Occupations) – Rich Katt, NDE State Director of Nebraska Career Education

There is a resurgence of WBL across the nation – NE is no exception. Proposed endorsement focuses on WBL knowledge and skills, as well as foundational knowledge related to legal considerations and workplace (business and industry) expectations. It also is noted that the endorsement will extend beyond the traditional use by Career and Technical Education teachers to other teachers engaged in WBL experiences, such as Special Education teachers. The endorsement provides 'some' legal protection for schools/teachers.

This endorsement will require work-based learning experience, but will not require the traditional principles of career education.

Action: Executive Committee consensus to move to move the endorsement forward to full Council consideration.

- Curriculum Supervisor Ad Hoc Committee Meeting 9.14.16
- Career Education Endorsements slated for Ad Hoc review beginning in Fall, 2016: Agricultural Education, Horticulture Education, Basic Business, Business, Marketing, and Information Technology (BMIT), Family and Consumer Sciences, Industrial Technology Education, Health Sciences, Information Technology, Skilled and Technical Sciences, Vocational Special Needs, and the Career Education endorsement (which can only be placed on a Career Education Teaching Permit).

## 3. NDE Updates – NDE Staff

- Middle Level and Special Education Supervisor Content Test Selection—Test Review Groups met July 12, 13, 2016.
  - Middle Level Tests (Math, Science, Social Studies, and English Language Arts)
    were selected and a passing scores recommended. Expected full implementation
    (individual must pass the test for placement of the endorsement on a certificate)
    on September 1, 2018. Institutions will have the option to request that
    candidates to take the tests prior to full implementation.
  - Test selected for Special Education Supervisor is the same test/score used for the Principal endorsement. Expected full implementation September 1, 2018.
     Institutions will have the option to request/require candidates to take the tests prior to full implementation.
- Janine Theiler has joined the Adult Programs Team with Educator Effectiveness responsibilities.

#### 4. Program Approval - Madsen

- Offsite Folio Review for College of Saint Mary and Wayne State College held June 27, 2016
- Offsite Folio Review for University of Nebraska-Kearney and York College scheduled for October 21, 2016 at Concordia Fallbrook, Lincoln.
