1. Log into NDE Portal
- *2. Click on blue tab: Student and Staff (NSSRS)
3. Click on link: Adviser Validation
4. Change Year to previous data reporting year (2018-2019)
5. Change Current District and Select
6. See left bar links and click on Verification Reports "Students"
- *7. Scroll down to Career Education and click on the row
8. Choose blue link: Programs of Study Courses
This opens the Programs of Study Report Site
9. Select most current Program Guide
10. Choose high school (if needed).
- *11. Select "Yes" or "No" to Only Show Offered Programs

Yes-Only Show Offered Programs- this will display programs of study met by a high school building with the enrolled number of students.

No-Only Show Offered Programs- this will display all the possible combinations for all POS in each of the 6 career fields. (Student enrollment is shown for courses offered at the high school.)

NOTE: Courses with 0 students cannot be counted as an approved Program of Study. If you know that at least one student took a specific course but 0 students are getting credit for the course, a variety of issues may exist. Review attached information with your Data Steward.

If a Program of Study has *** (3 asterisks) in the left column, it is designated as an Approved Program of Study when the "No" report in step 11 was selected.

- *12. Click on **View Report** button on right-hand side of selection window. The Program loads data for viewing. "Save as" Acrobat (PDF) file.

Click on "Log Out" or Main Menu for other options.

	<p>Does the High School follow Block Scheduling?</p> <p>NOTE: The Student Grades Verification Report COURSES will list reported courses by semester. It is possible one semester Student Grades was uploaded and the other not resulting in only half the credit for a course.</p>	<ul style="list-style-type: none"> ✓ Districts using block scheduling may have some courses that do not show up as year-long courses. NDE will devise an override on those courses that are required to be year-long. Within the Student Grades Template, DO NOT code block schedule courses as year-long courses unless they are offered year-long. <p>All of the CTE courses are defined by NCE course standards for one semester based on a 7-8 period day. The only exceptions are Accounting, Advanced Accounting, College Accounting, and any of the PLTW courses annotated above.</p>
	<p>Does the High School offer full-year courses?</p>	<ul style="list-style-type: none"> ✓ Some schools offer only year-long courses. Follow the steps identified directly above to properly identify content taught each semester. <p>Biennial Courses: If schools offer courses on an alternating year schedule, the biennial courses form must be submitted annually. 	<p>Is the course a High School course?</p>	<p>The only middle level course that can count for a program of study is Computer Applications. This course may be delivered at high school level or at 8th grade level. In either case Course Code 033422 must be a continuous 18-week course that matches 90 percent of the benchmarks.</p>
