AQuESTT:

Accountability for a Quality Education System, Today and Tomorrow

The State Board authorized Education Commissioner Blomstedt to set the AQuESTT business rules based on the recommendations of the Board's data committee. The business rules will address the distribution percentages for the accountability classification levels of Nebraska public schools and districts under AQuESTT as well determine how the Evidence Based Analysis (EBA) will factor into the final classifications and set the process for designating priority schools. The first AQuESTT results will tentatively be released to the public in early December. AQuESTT is a new state accountability system developed to support and reward continuous improvement for every child, school and educator.

ESEA FLEXIBILITY, WAIVER

Nebraska Education Commissioner Matt Blomstedt said yesterday that Nebraska will suspend its work on its waiver request at this time. Based on leadership changes in the U.S. House of Representatives, Nebraska is optimistic that Congress will move forward soon with the long overdue reauthorization of ESEA.
