- To hold a Commercial Learner's Permit for 14 days before taking the CDL Skills Test
- Show proof of US Citizenship or lawful status.

¹Part 382 – Types of tests required (CDL operators only):

1. Pre-employment
2. Random Testing
3. Post-accident
4. Return-to-duty
5. Follow-up

²Part 383 – P & S Endorsements

1. Route Transportation: P endorsement required; S endorsement required except private schools transporting post-secondary students
2. Activities Transportation: P endorsement required; S endorsement required only if it is a school sponsored event. S endorsement is not required for private schools transporting post-secondary students.

³Part 387 – Financial Responsibility (For-Hire Contractors Only)

1. Seating capacity of 16 or more requires \$5,000,000
2. Seating capacity of 9-15 requires \$1,500,000

*Part 387 does not apply if the activity is sponsored and paid by the School District
