

Praxis Updates for NACTE - October 2015

- **Score Reporting Enhancements:**
 - Institutional contacts are now receiving emails when new scores are delivered
 - Have ability to search by first AND last name
 - Annual History Report function includes Pass/Not Pass status and category raw points available
 - Advanced Search function includes category scores (earned and points available)
- Test vouchers (i.e. Emergency, Fee Waiver, Exception, Pre-Paid, School Sponsored) will be good for a full calendar year from the date of issue (previously 90 days).
- Simplified registration eliminates wrong choices – students enter system after choosing a state for a listing of tests

 - Important preparation step for students so they are familiar with the functionality of the Praxis computer test screens and navigation options on test day. Encourage your students to view this.
