Nebraska Certification

Criteria

- Valid for 2 years
 - Expires August 31 of the 2nd year following the year of issuance.
- Permit is NOT renewable
- Employment in a Nebraska school system is NOT required for this permit.
- Issued due to a deficiency in the Basic Skills Competency test requirement **AND/OR** the Special Education Training requirement **AND/OR** the recency requirement has NOT been met.

Requirements:

- Completion of a baccalaureate degree **AND**
- Completion of a teacher education program at a state approved teacher education institution **AND**
- Completion of the human relations training requirement
 - a. Official transcript of pre-approved course **OR**
 - b. Written, verified narrative of your K-12 employment experiences for the six (6) skills
- Submit completed Record of Residences NDE 20-0017 for immediate past five (5) years **OR**
- Fingerprinting, refer to Instructions: Fingerprinting for Nebraska Certification. Packets on request nde.tcertweb@nebraska.gov
- Complete online application
 - a. Online: <https://online.nedoe.org> and pay non-refundable application fee
 - b. Paper: download the Teacher Application from the website www.education.ne.gov/tcert. Complete and mail to the Teacher Certification Office with check or money order.
- Institutional Verification for Nebraska Educator Certificate or Permit NDE 20-016 completed by the Certification Officer with the institution where your program was completed **AND**
- Legible copy of your current, valid out of state teaching certificate (if applicable) **AND**
- Complete Verification of Employment Experience for Postsecondary Permit NDE 20-024 **AND**
- Order official transcripts. **AND**
- Download District Agreement State Provisional Permit NDE 20-002, complete top section (if applicable)
