Declaration of Legal Meeting and Open Meetings Act: Stated by P. Spethman at 9:38 a.m.

<u>Approval of October 13, 2017 General Session Meeting Minutes</u>: Motion by Jankovich to approve the minutes; seconded by Marymee. Roll call vote taken. Motion approved.

<u>Report of January 26, 2018 Executive Committee Meeting</u> – P. Spethman reviewed the minutes from the January 26, 2018 meeting.

Stakeholder Updates -

Nebraska Association of Colleges of Teacher Education (NACTE) – P. Blundell; Data use is a major tool for HED Institutions. The follow-up surveys for 1st & 3rd year teachers contain information critical for HED

programs. Need to stress to administrators the importance of completing these surveys. Work is continuing on statewide clinical practice rubric. There is support for Educators Rising; topics of recruitment and retention of teachers is a continuing discussion.

Nebraska Community College Association (NCCA) – G. Adams for P. Illich; A primary issue is the squeeze with appropriations from the legislature. Need for funding is greater now for community colleges. One difficulty is capacity, as there are not enough facilities available for potential students, and the waiting list is growing. Remedial education is another area of difficulty for incoming students. A pilot program in all 6 community college regions is going to be implemented with the college faculty working with incoming students to help those with difficulties in areas such as math, reading, etc.

Nebraska Association of School Boards (NASB) – J. Vlach; Are watching current legislative issues. NASB is in total agreement with the NDE perspective on these legislative issues. Property taxes is an ongoing issue, with population wanting a break on property taxes. Other important issues under discussion include dyslexia, and available student mental health services.

Nebraska Council on School Administrators (NCSA) - M. Adler; NCSA is not in favor of eliminating the State Board. NCSA is currently working on supporting emerging leaders in the school systems. Mentoring possible new leaders is a positive thing. Also work is being done to highlight the good things going on in public schools, such as the 'I Love Public Schools' campaign.

Nebraska State Education Association (NSEA) – J. Sears; Watching bills in legislature and the possible effect on education. NSEA field staff are working with 'Educators Rising' students, as well as helping candidates be prepared for Praxis Core tests. Dr. Copich at NSEA received a 3-year grant from NEA targeting teachers in outlying areas, and providing professional support for new teachers as well. Professional development is a major issue, especially in the areas of trying to work with students dealing with trauma and other issues.

Legislative Update – J. Sears; reminded the group that NDE is an advisory board for state education. Sears explained various bills before the legislature and how they can affect the education process.

Nebraska's Early Childhood Workforce: A Focus on Caregivers and Teachers – Dr. Susan Sarver, Buffett Early Childhood Institute Director of Workforce Planning and Development; Much statistical data reflecting the current state of Nebraska Early Childhood personnel was given. Many different groups are providing childcare, but these groups are seldom working together. Dealing with other agencies such as DHHS and NDE is difficult when each agency requires different standards. Wages and benefits are low for caregivers, and this needs to be addressed.

Teach to Your Power, Educators Rising, and Education Preparation Pathway – C. Packard, NDE Health Sciences Curriculum Specialist; Educators Rising organization, in partnership with NSEA is growing in membership and beginning to expand to more school districts. State Leadership Conference was recently held with over 500 students and various vendors attending. There is a need to educate students on what is

involved in becoming a teacher, including passing the Praxis test, which Educators Rising is addressing. Educators Rising also promotes other avenues for educators for those who don't necessarily want to teach. Students need to know there are different tracks for educators. Another focus for Educator's Rising is the inclusion of the diverse student population in trying to encourage them to become teachers. Educators Rising is the student organization for the Education and Training Cluster.

Teach to Your Power – Want to capture students who are passionate about a subject and get them into teacher preparation programs.

Rule Status Reports - P. Madsen, NDE and K. Peters, NDE Director of Teacher Certification

- Rule 24 approved by State Board on February 2, 2018; currently awaiting AG approval.
- Rule 21 K. Peters, NDE; Rule 21 will include a military teacher permit and will be signed by Governor on March 19, 2018. This will give a 3-year permit with a certificate from another state, and a job. Rule 21 also states that to renew a NE certificate certain substitute teaching experiences done while student teaching or teaching in a community college can be used in meeting renewal requirements.
- LB 1135 K. Peters, NDE; says a teaching certificate from another state should be allowed to gain a NE certificate. The bill also talks about alternative certification possibilities for use in Nebraska.
- Rule 23 K. Peters, NDE; The Rule changes include using a composite score for the Core Academic Skills tests
 with no qualifiers as in current language, but it appears there is some concern about this from the Governor's
 Office. There also needs to be some consideration to having one Human Relations course that is online (rather
 than over 70 courses available) and the number of hours required to renew an expired certificate (6 hours and
 15 hours) is a huge barrier to those who want to return to teaching. Content test scores also need to be
 reviewed and an acceptable pass rate need to be determined.

- 1st Year Teacher Employer Survey and 1st Year Teacher Completer Surveys will be emailed mid-March. Please respond! Institutions use the survey results to inform continuous improvement.
- Clinical Practice Rubric Update Barbara Sunderman (Hastings College) and Chris Wilcoxen (UNO); Explained and demonstrated the various sections of the new Clinical Practice Rubric, which will be effective beginning with the Fall, 2018 semester.

Educator Effectiveness Update - Sara Skretta (UNL) and Jay Sears (NSEA)

- Network for Transforming Educator Preparation (CCSSO) Teacher Ready/Administrator Ready Document covers a lot of CCSSO discussion
- School Ready Learner Document and Next Steps What do teachers need to know when they first start teaching? What does NDE need to do on a policy / regulation side to help beginning teachers? How do we work with a diverse learner initiative?

Health sciences teacher numbers would grow with a field endorsement, which would be included in Rule 24 by August 1, 2019 provided all approvals are given at the various levels. Health Sciences is the only career field which does not yet have a field endorsement.
