SCOPE

This collection is for <u>select districts</u> that NDE Approval and Accreditation identified as having possible Rule 10 instructional unit violations using previous year Student Grades data. The districts that need to complete the collection will be notified. The data collected will be course offerings for the current school year for schools with grades 9 through 12.

If an error is discovered on the Student Grades reporting for 2014-2015, you must still complete the Instructional Units Report. The data in the CDC Instruction Units will reflect the 2015-2016 courses and schedule. If you want to make corrections to the 2014-2015 Student Grades, complete the CDC Request to Submit Data Late or Make Data Changes.

DUE DATE

This collection is due October 16, Audit Window Close Data October 31st.

DIRECTIONS FOR COMPLETING

The Instructional Units collection is found in the Consolidated Data Collection through the NDE Portal.

The Consolidated Data Collection (CDC) is a system designed to collect data for Federal and State reporting that is not collected through the Nebraska Student and Staff Record System (NSSRS). CDC is a data collection available on the NDE Portal. The NDE Portal is available via a link on the NDE homepage: www.nde.state.ne.us or by directly accessing the link: http://portal.nde.state.ne.us

Find the Collection:

- 1) Log in to the portal > Click on the tab for "Data Collections"
- 2) Choose "Consolidated Data Collection (CDC)
- 3) From the "Open Collections" list, choose "Instructional Units"*

*Appropriate user types for this collection are "General User", "All user" and "Approver". A user will not be able to get into this collection unless they have entered an appropriate activation code given to them by their administrator. If a district is not required to complete this collection, when trying to access the collection a message will display that the district is not required to complete.

GENERAL INSTRUCTIONS

Districts will be required to submit minutes per session and sessions per year for all courses being offered for the current school year. Districts will be presented a list of schools with grades 9-12 with the subjects/courses that were offered during the previous school year. Districts will need to enter minutes per session and sessions per year for each course in the list. Districts can add courses not listed or delete those not being offered. Also included in this list is a field called "Noncompliance". If the school is out of compliance in a particular subject, it will be indicated by an "X".

Instructional Unit means 15 clock hours (900 minutes) of classroom instruction in a course offered in the secondary school and includes only grades 9-12. As an example, a course which meets for 50 minutes a day for 180 days generates 10 instructional units. Minutes Per Session times Sessions Per Year divided by 900 is how NDE will calculate the Instructional Units.

Report the minutes per session and session per year for courses offered to students in grades 9-12. Districts may include courses that are dual credit, online courses and distance learning. At least one student must enroll in the course to count for instructional units; this rule will not be enforced until after Student Grades is completed for the school year.

Do not include any summer school courses.

If the school is grades 7-12 and some classes apply to grades 7-8 and 9-12, use the minutes per session and sessions per year for the 9-12 courses.

If more than one section of the course is offered for students in grades 9-12, report the minutes per session and sessions per year that will calculate the highest instructional units.

The submission can be done using the on-line form or the district can download a file, update the file and re-upload into the Instructional Units Collection.

Instructions For Completing The Form On-Line

Access the Instructional Units collection as mentioned above. Click on the "Instructional Units" link once in the CDC. If you are not required to complete this collection you will get a message stating this:



Once in the collection, all schools will be listed for the district that contain grades 9-12. Each school listed will need to be completed before the collection can be submitted and approved.

Download/Upload File

If you are preparing your file for upload in Excel, check that Excel does not distort your data. (See "Download and Upload Instructions" above for more detailed information on the upload.) Make sure that your columns in the Excel spreadsheet are formatted properly. All columns should be formatted as "Text" fields except for "Minutes" and "Sessions" which can be formatted as numbers (integers). For instance, if your district number is 0001, if the county column is not formatted as a text field, Excel will read the column as a number and drop the leading 0's, changing the "0001" to "1". When you upload the file, you will receive an error stating the district number is not valid. If you are using the File Download from the Instructional Units collection, remove the following columns that were included in the download file: DISTRICTNAME, SCHOOLNAME, SUBJECT_LITERAL, COURSE_LITERAL, NONCOMPLIANCE as these are not required. Header row can be included as long as they follow the record layout naming convention.

NOTE: Once you have a successful upload for all schools involved, go back into the form for each school. Check your data to make sure all changes were made and any subject/courses that were added are in the file and delete the courses that will not be offered. Once you are satisfied that the data is correct, click on the "Completed" button on the form. This will put a green check mark next to the school on the main page of the Instructional Units collection. This form can then be submitted and approved (follow "Submission" instructions).

SUBMISSION

Upon completing data for all locations, click on the **Submit** button. This will acknowledge that you have completed the data and it is ready for review by your District/System Administrator. Once the District/System Administrator has reviewed the Instructional Units collection, the District Administrator can click on the **Approve** button to submit the information to NDE. Once the collection has been approved, you will no longer be able to make changes. If changes need to be made, you will need to contact the Helpdesk at (888) 285-0556 to re-open the collection if it before the Audit Window Close date.

Press the View Summary Report button for a report of all data submitted.

<u>NOTE</u>: Only the person who is designated as District/System Administrator for the Instructional Units Collection in the CDC system will see the **Approve** button in the box below the **Submit** button. The District/System Administrator can **Submit** and **Approve** the collection.
