Content pass rates Discussion: Questions that were raised included:

- What is the purpose of setting the pass rate?

- What will happen if the established pass rate is not met?
- Will this be for all institutions or just specific institutions?
- Will institutions be required to have a plan to raise the rate?
- It was concluded that more information needs to be gathered before setting a cut rate score.

It was determined that the proposal to change the content test for Early Childhood Special Education be postponed until all institutions that offer that endorsement have an opportunity to voice their opinion.

Meeting Dates Discussion:

March 8 and June 7 are the preferred dates for the upcoming 2019 NCTE meetings. It was thought that Fridays are the best day for the meetings to occur.

Suggested topics and themes for NCTE to address during 2018-19 and 2019-20:

- Requirements for entrance into teacher education
- Vouchers and charter schools
- Cooperative ventures to recruit and retain teachers
- NCSA ambassadors and their work

Proposed Health Sciences field endorsement discussion:

It is noted that all the other career fields have field endorsements and that having only a supplemental endorsement makes this endorsement seem less important. On the other hand, it might be difficult for institutions to offer this endorsement. It would be good to continue the supplemental endorsement along with the field endorsement.
