NDE Highlights

CARES ACT

- Nebraska total \$65 million
 - NDE reserving 10% \$6.5 million
 - Must be used for emergency needs resulting from COVID-19
 - School districts \$59 million
 - Allocated based on 2019 Title IA formula
- Fund use should be to prepare for, prevent, or respond to COVID-19
- Public school districts are required to provide equitable services to nonpublic school students with their allocation of ESSER funds
- Commissioner intends to apply for ESSER funds by May 22, 2020
