Suicide Awareness/ Prevention Training

For School Personnel



Nebraska §79-2, 145 & 146 Five-Year Plan ● 2020-2025 This content includes a brief overview of the training options that are approved for school personnel.

Highlights of each option are included to assist in making decisions about how to best meet the needs of staff in your district.

Per Nebraska Revised Statute 79-2, 145 & 146:

School personnel will have at least one hour of suicide awareness and prevention training each year,

Intent of the law:

To equip school personnel with information that could save the life of a student; recognizing signs and symptoms of suicidal behaviors and methods of responding to students in crisis.

Required Audience:

All public school nurses, teachers, counselors, school psychologists, administrators, school social workers, and any other appropriate personnel are legislatively mandated to participate.

Schools should also consider including any school staff member having contact with students (para-professionals, administrative/secretarial staff, bus drivers, custodians, kitchen staff, etc.).





- Provide equal access to quality training for all school staff members statewide.
- Create statewide focus of training toward suicide prevention. As teachers move to different schools, districts can be assured teachers have previously received adequate training in suicide awareness/prevention.
- Afford teachers and staff opportunity to enhance assets for personal resume.
- Construct systems across public and non-public schools, also including education majors in higher education across our state.
- Collect statewide data to support and inform future decisions about youth suicide awareness/prevention training.
- Select statewide training emphasis based on Nebraska needs and data.
- Create common suicide prevention and language.





§ 79-2,145 & 79-2,146

- Per 79-2, 145 & 79-2,146: At least one hour of suicide awareness and prevention each year.
- INTENT OF THE LAW: To equip school personnel with information that could save the life of a student recognizing signs and symptoms of suicidal behaviors and methods of responding to students in crisis. School personnel are critical components of a suicide



Target Audience

- TARGET AUDIENCE: Any school staff member having contact with students (i.e., in addition to required audience, para-professionals, administrative secretarial staff, bus drivers, custodians, kitchen staff, etc.).
- 79-2, 145 & 79-2,146 REQUIRED AUDIENCE: All public school nurses, teachers, counselors, school psychologists, social workers, administrators and any other appropriate personnel are legislatively mandated to participate.





Selection of Programs

- Programs with an evidence-base are priority for inclusion. The requirement for inclusion is to be listed on the National Registry for Evidence based Programs and Practices (NREEP), and the National Suicide Prevention Resource Center (SPRC) Best Practice Registry.
- Data and plans will be evaluated and revised at the end of five years to include additional programs with an approved evidence and capacity for delivery to all Nebraska Schools.

Community

- This <u>free training</u> designed for faculty and staff at all levels within schools. It introduces concepts that will help
 you understand what to do if a student is contemplating suicide, and how to ensure your school can
 appropriately respond to a suicide using postvention measures.
- There are three online training modules. Complete two of the three modules for the one-hour suicide prevention training requirement. All modules have short video PowerPoints & links to hand-outs and resources for:
 - Understanding suicidal thinking & helping suicidal students
 - Planning & responding in postvention following an attempt or death by suicide

Highlights:



Each module has a brief presentation with videos, followed by a short quiz and links to valuable resources. Staff can select from:

Module 1 - all staff- understanding suicidal thinking; helping suicidal students; postvention

Module 2 - educators and staff - postevention - suicide attempt- re-entry; death by suicide

Module 3 - administrators and professionals (school counselors, social workers, nurses, psychs. etc.) - role in responding to suicide attempt; role in preparing and responding after a suicide



The Jason Foundation

Online option, free. Choose 1 module for the one-hour requirement. Certificate provided upon completion. Register for the module here: <u>Jason Foundation Professional Development Series</u>

- Bullying and Suicide Describes the connection between bullying and suicide & provides recommendations for proactive interventions. Special challenges for LGBTQ youth are noted.
- Childhood and Teen Depression for Educators Offers signs & risk factors associated with youth depression, as well as actions educators can take to assist & build protective factors.
- Suicide Postvention: the Critical Role of Educators Suicide Postvention Offers strategies for schools in supporting students and staff following a suicide or attempt, with an emphasis on steps to prevent contagion. Attention is also given to how to address social media in prevention and postvention efforts.
- Supporting LGBT Students in School: Suicide Prevention Among LGBT Youth Provides a discussion of depression, warning signs, and suicide risk in youth in general, with a special focus on the added pressures faced by LGBTQ youth. Data supports that this population is at far greater risk of mental health concerns and suicidal behaviors, needing strong intentional support in the school environment.
