A scholarship for teacher education students allowed for targeted enrollment in new endorsement areas. Increased collaboration with science content faculty and teacher education students increased the exposure of new students to the science major. Completion of an environmental and ecological simulation in the Science department increased interest in more hands-on learning opportunities for prospective teachers.

1. Increase collaboration with Biology faculty to design STEM professional development for preservice teachers and professional teachers through the use of Greenhouse and ecological simulation model. 2. Foster partnerships with local middle schools and high schools to participate in research and learning in real-life applications of ecology. 3. Integrating Technology Effectively into Curriculum and Instruction: A dedicated course called Instructional Technology for Teachers (EDUC220) is required of all teacher education majors; all teacher education courses are embedded with technology. Students are introduced to a variety of technological tools in EDUC 220 and then see those tools integrated into a variety of courses throughout their time in the program (EDUC 240, 340, 360, 400). Tools include but are not limited to: Nearpod, Padlet, Mentimeter, Flipgrid, Mursion, Office 365, Google Classroom, and all students participate in creating a curated list of technological resources and learning tools to provide models for students of how technology could be used in the classroom. ; On-line coursework demonstrates how technology can be used in teaching in all content areas; Field Experience simulation software gives targeted classroom situations for students to engage in within the methods classroom; Capstone assignment of Teacher Work Sample teaches preservice students how to use technology to collect, manage, and make instructional decisions based on an analysis of student needs; Classroom design includes technology tools for use in the classroom including Smart Boards, laptops, computer speakers, headphones, video cameras (SWIVL). Use Technology Effectively to Collect Data to Improve Teaching and Learning: In a variety of courses as students move through the program, they are exposed to various ways to plan and use assessment data (Intro to Exceptional Children (EDUC260), Assessment and Evaluation (EDUC410), Secondary Methods (EDUC420), Field Experiences (EDUC 240, 260, 340, 420) and Student Teaching (EDUC450). In addition to using Microsoft Forms, OneNote, and Blackboard for summative data, technology such as Forms, Nearpod, and Mentimeter are used to collect formative data to

determine student progress and growth throughout their courses. The Final Capstone assignment of the Teacher Work Sample leads the student through the creation of a variety of assessment tools to collect data electronically and use the Universal Design techniques to plan individualized instructional strategies such as assignment choice, flexible assessment, group work, project-based learning, student-centered learning techniques. Use Technology effectively to manage data to improve teaching and learning: Preservice students are exposed to data management in Classroom Management (EDUC400) and learn how to use grading software, online assessments, and enhanced record keeping. Bellevue University's Learning Management System (Blackboard) is used in addition to Microsoft Office 365 tools such as Excel, Forms, and OneNote to manage data. Through field experiences and student-teaching they learn specific data collection tools used in the schools in which they are working; In methods coursework and student teaching, they learn how to plan using virtual lesson plans. Use Technology Effectively to Analyze Data to Improve Teaching and Learning: Students learn the Universal Design method in Intro to the Exceptional Child (EDUC260) and implement these methods in Secondary Methods (EDUC420), Field Experiences (EDUC 240, 260, 340, 420), and Student Teaching (EDUC450) through the planning of individualized learning. They use technology to provide alternative modes of representation in a variety of learning strategies. Other technology tools used for data analysis include digital education tools, social networking, online teaching, class blogs, wikis, podcasting, interactive whiteboards, and mobile devices. "Forms" provides an opportunity for students to provide feedback in individual courses at the conclusion of the semester

a. Teach students with disabilities effectively

All students take a dedicated course in teaching children with disabilities, Introduction to Working with Exceptional Children (EDUC260). In this course, they learn about the various disabilities, characteristics of children with these disabilities, assessment and evaluation of special needs students, and classroom strategies for working with different disabilities. Preservice teachers learn Universal Design techniques for identifying specific ways to individualize learning and apply those strategies to the RTI levels of instruction. All students must prepare lesson plans using UDL principles and demonstrating how to individualize specific lessons. All lesson plans in subsequent courses in the program all require special needs modifications. Students also participate in a practicum for 25 hours in classrooms with special needs students EDUC 262).

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

All students take Intro to Exceptional Children (EDUC260) and learn the process of assessment and evaluation of special needs children including the responsibilities of the regular classroom teacher in the IEP process. Students also participate in a practicum in a regular classroom (EDUC262) that inclusive of special needs students. If possible they observe an IEP meeting with the cooperating teacher at that time. During the Student Teaching semester, they also participate in IEP conferences and create a Teacher Work Sample to demonstrate their knowledge of the process of evaluating and assessing student needs and planning for instruction.

c. Effectively teach students who are limited English proficient.

Students complete courses that address the needs of students with limited English proficiency. (Human Relations (EDUC230), Intro to Exceptional Children (EDUC260), and Secondary Reading and Writing Across the Curriculum (EDUC360). They also are assigned practicum hours (up to 170 hours) in schools with high populations of ELL students (EDUC 340, EDUC362, EDUC340, EDUC420). Students complete discussion boards about experiences in the classroom with ELLs, case studies of individual ELL students, and inclusion of lesson plan strategies for ELLs.
