Evaluate the influence of mental illness symptoms on extremist beliefs.

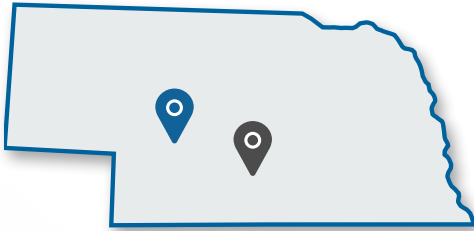
