#### **Status of Rules in Approval Process:**

- Rule 20 At Attorney General's office for review before moving forward to governor for approval
- Rule 21 At Attorney General's office for review before moving forward to governor for approval
- Rule 24 At Attorney General's office for review before moving forward to governor for approval

The State Board is working on the revision process, so Rules 21 and 24 will be opened, as the State Board is working on revisions for these rules. Due to a backlog at the Attorney General's office, Rules 20 and 24 might take longer for processing.

- Bill 705 influences education, along with the implementation of other bills

#### Status of Rule 24 Endorsements in the Review Process: Micki Charf, NDE

- Ad Hoc recommendations include:
  - o Name change to **Early Childhood Special Education** endorsement.
  - Section 006.60D Added the words "undergraduate or" when referring to the minimum number of semester hours of course work needed in Early Childhood Education and Early Intervention/Early Childhood Special Education.
  - Section 006.60D1 Completely eliminate this section.



## **Nebraska Council on Teacher Education (NCTE)**

- Executive Committee Recommendations:
  - Section 006.60D Remove the words "undergraduate or graduate" when referring to the number of semester hours of course work needed in this section.
- Motion to advance this endorsement for approval at the October 6 NCTE meeting made by Stake; seconded by Jansky. Motion approved.

  - Repeat New Member Orientation Process that was done in 2022.
    - Executive Committee Orientation meeting will be held with new members prior to the start of the October 6 full council meeting. This meeting will explain the purpose of NCTE and how the NCTE meetings work.

  - o Highlight and emphasize that the NCTE and NACTE are different organizations.
  - Explain and review the purpose of the NCTE because it is an advisory group to the State Board. However, it is noted that the NCTE is not an advisory group to NDE.
  - NCTE membership numbers provides various views, multiple aspects and discussions, and input from across the state regarding education in Nebraska. The value of the diverse composition of membership and the size should be specifically addressed.
  - o Power Point presentation will be incorporated into presentation.
- Request will be made to present the annual NCTE report to the State Board at the September meeting.
