Encouraging Collaboration with Content Area Teachers

Many school districts in Nebraska and across the country are experiencing tremendous growth in the area of English learners. This year, 2023-24, we tested over 29,000 English learners with the ELPA21 Summative and Alt ELPA Assessments. Nebraska Rule 15 provides guidance for our state in the areas of welcoming and identification, staffing and professional learning, language instruction educational programs, ELP standards, assessments, and accommodations, and exit requirements.





As with all students, one teacher can not do it all.

Collaboration is an essential element for districts to address the various needs of their students. While it can be very beneficial to have an English learner specialist in a school and district, there are a number of great resources to build the capacity of those districts that do not have this expertise. Our ESU Title III Consortiums are a wonderful resource to support smaller districts who have English Learners. (ESU 3, ESU 4, ESU 6, ESU 7, ESU 10, ESU 13, and ESU 15)

We have a number of large districts who have been working with the English learner population for many years and they can be a wonderful resource for those districts who are new to the EL/ML population. Omaha Public Schools is our largest district and their program for English learners includes 19,724 current students who have been provided English learner services. Other large districts across the state include Lincoln, Grand Island, Lexington, Fremont, and South Sioux City.

One of the districts new to having ELs/MLs this year is Thayer Central. Thayer Central called our office and we provided a few all-staff presentations via zoom. We also offered support through our Canvas courses. I just spoke to the elementary principal, Eric Hoops, and he said the students are doing well. One student is very outgoing and learning very quickly. The other student is more reserved and shy so they are learning how to best work with her. Just like all students, there are many factors that contribute to their learning. Students come with various background experiences, and a



variety of different aptitudes, personalities, and interests. When all teachers and district leaders work together to support each and every student, great things can be accomplished for our EL/ML students. Great work - Thayer Central!!
