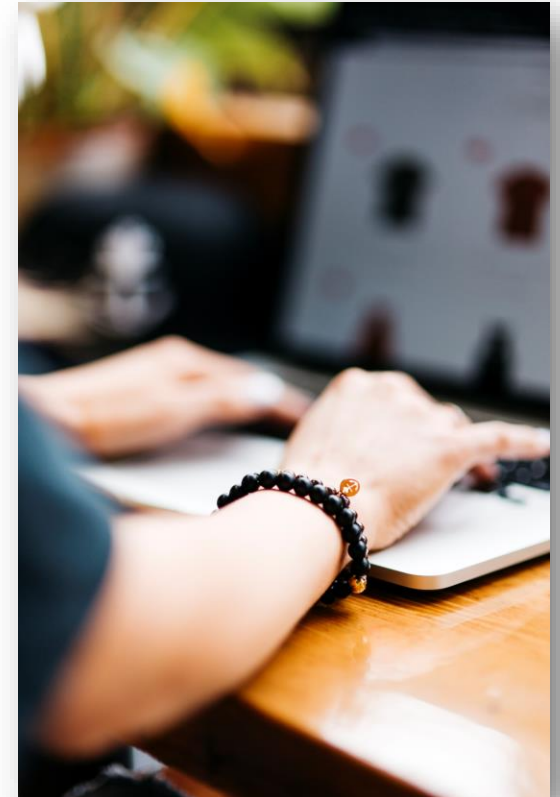


Modernized NDE Portal

Access via Roles

NDE will create and manage Roles with groups of application permissions

Examples:

- District Administrator
- Data Steward

New applications/permissions added to a Role will automatically provision Role-holders with that access. Individual application access still available for assignment.



Access to Collections

- District Admin/Proxy can assign Access

-- Or --

- District staff can request Access
 - Must be approved by District Admin/Proxy

Portal Data Collections

- Rewrite of legacy applications to take advantage of new portal security and other features
- Some rewrites will launch in the existing portal prior to Modernized Portal going live
- Consolidated Data Collection (CDC) will be phased out and the individual collections will be presented separately or otherwise grouped
- Both portals will need to function simultaneously while legacy applications are brought into the new portal
