The Nebraska Seal of Biliteracy, established in 2020 with support from the Nebraska Languages Association (N(II)LA), recognizes high school students who have achieved proficiency in English and at least one additional language upon graduation. Since its inception, over 1,200 students have been honored with this distinction, highlighting their linguistic and cultural competencies.

About the Nebraska Seal of Biliteracy

The Seal is awarded at three levels:

- **Silver Level:** For students demonstrating Intermediate-Mid proficiency, indicating the ability to handle familiar topics and everyday communication.
- **Gold Level:** For those achieving Intermediate-High proficiency, showcasing stronger language control and the capacity to engage in more complex conversations.
- **Platinum Level:** To be introduced in August 2025, this highest distinction will be awarded to students attaining Advanced-Low proficiency or higher, reflecting effective communication across a wide range of topics, including in academic and professional contexts.

The impact of the Nebraska Seal of Biliteracy continues to expand, aligning with nationwide efforts to recognize multilingual proficiency. Five Nebraska institutions of higher education have committed to awarding academic credit to Seal recipients, providing students with tangible benefits in their postsecondary education.

Additionally, six businesses and twelve organizations across the country have pledged to acknowledge the Seal in their hiring and community engagement practices, reinforcing the value of language skills in today's diverse workforce.

By joining the national network of states offering the Seal of Biliteracy, Nebraska continues to promote language learning, cultural appreciation, and real-world opportunities for students, ensuring they are well-prepared for success in college, careers, and global engagement.



Qualification

To be awarded the Nebraska Seal of Biliteracy, applicants must demonstrate language proficiency in both English and another language. For English, applicants are required to provide evidence of proficiency at the Intermediate Mid-Level on the ACTFL proficiency scale.

As for the other languages, there are three levels of recognition:

- Silver Level – Intermediate Mid
- Gold Level – IntermediateHigh
- Platinum Level – Advanced Low

The following section will describe the eligibility requirements for English proficiency and other language proficiency in detail.

English Eligibility Criteria

To be eligible for the Seal of Biliteracy, students must demonstrate their proficiency in the English Language. To determine a student's level of English proficiency, any of the following evidence is acceptable:

- Six COMPLETED semesters of ELA coursework (including AP English courses) with a grade of C or above (College Board scale: 73%). Current classes in progress do not count.
- ACT: composite/ ELA 18
- AP English Language & Composition Test : 3
- SAT Reading & Writing score: 480
- ELPA 21 - Combination of Scores of 4 - High School
- STAMP 4 S English Proficiency: 5
- AAPPL- I3

EL students

- EL students should submit ELPA 21 results they received in high school. If EL students exited the program before high school, they should not use ELPA 21 results as evidence for the Nebraska Seal of Biliteracy application.
- EL courses are not accepted as proficiency evidence for English.

International Schools English Credits

Courses that are English as a World Language will not be counted.

Courses that are in an International School, American, or British Schools will count



Other Language Eligibility Criteria

To be eligible for the Seal of Biliteracy, students must demonstrate proficiency in a second language through one of the following options:

Transcript evidence (Heritage/Native Spanish-Speakers): students with the following courses explicitly stated on their high school transcripts could qualify for a Seal:

- A combination of six semesters of Honors Spanish, Spanish for Spanish-Speakers, AP/ IB Spanish classes with a grade of C or above - Silver
- The above classes + dual language/ immersion courses (with a C or above) - Gold
- Four semesters of Spanish for Spanish Speakers with a C and above with Dual Language courses - Silver

Students with six English Language Arts (ELA)-equivalent classes taught in a language other than English in a non-English-speaking country qualify for a Silver Seal. To qualify for a Gold Seal, they must take these AND six other content-based classes taught in that language. These might include social studies, science, math, and other subjects. This route needs verification of instructional language, such as a transcript from the country.

Proficiency test results: The following are examples of nationally recognized proficiency tests, which assess a variety of languages, and their respective scores indicating seal eligibility. Please contact Dr. Chrystal Liu for questions about additional proficiency.

Application Process

The Nebraska Seal of Biliteracy application opens three times per year, with submission deadlines on April 1, August 1, and November 1. There are two ways to apply for the Nebraska Seal of Biliteracy:

- Individual application
- School application

Individual Application

Students may apply for the Nebraska Seal of Biliteracy independently. All applications must be submitted within the time frames, and late applications will not be accepted. Students are encouraged to communicate with their World Language teachers concerning requirements, preparation of the proficiency evidence, and the application process.

Students who plan to use their high school transcript as evidence of English language proficiency are encouraged to apply during the first semester of their senior year. This allows them to receive initial feedback and, if necessary, complete any missing requirements in time for the April 1 deadline, ensuring they can still earn the Seal before graduation. Applying early allows students to meet the requirements while also allowing them to highlight their Seal of Biliteracy achievement on college applications, showcasing their academic dedication, and on résumés and job applications, demonstrating their multilingual skills and making them more competitive in an increasingly global job market.

It is recommended that schools (or World Language teachers, counselors, or administrators) share information about the Nebraska Seal of Biliteracy with students in their freshman year so that they can start planning early in order to meet the requirements.

Once students are ready to apply, they must gather proficiency evidence for both English and the additional language they are applying for. Then, they should visit the Nebraska Seal of Biliteracy website and follow the application link. Detailed instructions are provided within the form to guide applicants through each step of the process.



School Application

Due to a significant increase in the number of applications since 2020, it is recommended that schools and districts submit applications on behalf of their students. Each participating district or school must appoint a Seal of Biliteracy Liaison to coordinate the application process. The responsibilities of the liaison include:

- Obtaining parent or guardian consent for:
 - Submitting a school-level application on behalf of students
 - Including student names in the NDE news release announcing awardees
- Completing the required spreadsheet with information for all student applicants
- Compiling a single PDF file containing English proficiency documentation for all students
- Compiling a single PDF file containing documentation of proficiency in the partner language(s)
- Submitting the complete school application by the posted deadlines: April 1, August 1, and November 1.

Medallion Purchase (Medallions are available for purchase, but not required):

Medallion purchases can only be made during the following time frames: . Orders submitted after the deadlines listed below will not be processed.

- April applications: December 2nd – April 5th;
- August applications: May 2nd – August 5th;
- November applications: August 2nd – November 5th.

Review Process

Review of Seal applications begin after the April 1st, August 1st and November 1st due dates. Materials submitted after the due dates will not be accepted.

The review of applications is completed by the Seal of Biliteracy Advisory Board teams through multiple review sessions to accurately assess proficiency levels of the applicants. The review of submission materials begins 4-5 days after the closing dates for each round and is completed by the 20th / 21st of the month indicated.

The preliminary session reviews the student-submitted materials in two teams. The first team assesses the English Proficiency materials (ONE of the following) for each applicant:

- Six COMPLETED semesters of ELA coursework (AP English courses) with a grade C or above; current enrollments do not count.
- ACT: composite score / ELA score: 18+
- AP Test Score: 3+
- An SAT score: 480+
- ELPA 21 - Combination of Scores of 4 - High School
- STAMP 4 S score: 5+

The second team in the preliminary session reviews the material submitted for Target Language Proficiency (ONE of the following) for each applicant:

- Transcript (Heritage/Native Spanish Speakers)
- STAMP 4S score: 5+
- AAPPL score: I3 +
- ALTA score: 5+
- AP Test score: 3+
- IB coursework score: 4+
- CEFR-aligned tests A2 for Silver, B1 for Gold, B2+ (advanced low and above) for Platinum

Once the preliminary session of reviews is complete, the second session is completed by a third team that reviews all materials and notes from the preliminary session. After both review sessions are completed, Seal awardees will be notified by the 25th of the month.

Applicants and educators should ensure that all materials are submitted in a timely manner with correct and accurate information so that applications can be processed in a timely manner.



Seal of Biliteracy Advisory & Review Board

To ensure the quality and validity of the Nebraska Seal of Biliteracy review process, the NDE World Language Education team established the Seal of Biliteracy Advisory Board. The board meets at least six times each year. This board serves on a two-year term and works collaboratively to:

- Monitor the Nebraska Seal of Biliteracy requirements
- Review the Nebraska Seal of Biliteracy applications
- Revise and update the Seal of Biliteracy application form
- Standardize the Seal of Biliteracy application process

The 2025–2027 Seal of Biliteracy Advisory Board includes representatives from K–12 education, higher education, and the Nebraska Department of Education. Members are Dr. Christopher Jacobs (University of Nebraska at Kearney), Dr. Chrystal Liu (Nebraska Department of Education), Danielle Fulcher (Lincoln Public Schools), Gwen Fisher (Creighton Preparatory School), Dr. Janet Eckerson (University of Nebraska at Kearney), and Hannah Paredes (Omaha Public Schools). Together, they bring diverse perspectives and expertise to ensure the Seal of Biliteracy remains a credible and meaningful recognition of students' multilingual achievement.

Seal Endorsement - Higher Ed

The Seal of Biliteracy has made a significant academic impact by providing students with opportunities to earn college credit for their multilingual skills, with nearly 90 universities nationwide offering credit under their own conditions ([see list here](#)). In Nebraska, five institutions — University of Nebraska–Lincoln (UNL), University of Nebraska–Omaha (UNO), the University of Nebraska at Kearney (UNK), Doane University, and Wayne State College— recognize the Seal's value. Some go even further to support access: UNK began to administer and proctor the STAMP 4S assessment in 2021, UNL began in 2023, allowing students to take it on campus free of charge to apply for the Seal — thanks to the leadership of Dr. Nora Peterson and Dr. Rigoberto Guevara. With the effort of Dr. Janet Eckerson, UNK has offered the assessment since 2021, coordinating with the registrar's office so that students can complete both a campus visit and the STAMP 4S on the same day. These efforts illustrate how universities can actively promote biliteracy and support student success in higher education.

Seal Endorsement - School District

Omaha Public Schools (OPS) has become a leading example of how a district can fully integrate the Seal of Biliteracy into its educational system. OPS officially recognizes the Nebraska Seal of Biliteracy as a special diploma distinction, recording it on students' transcripts to honor their multilingual achievement. The district has also developed a mini-course to guide students through the Seal application process and to help teachers support their students in earning this credential. Demonstrating strong local ownership, OPS is currently working with the Nebraska Department of Education's World Language Specialist to establish a Memorandum of Understanding (MOU) that will enable the district to review its own student applications under the NDE guidance. This partnership underscores OPS's commitment to biliteracy and sets a model for how school districts can endorse and implement the Seal in sustainable, student-centered ways.
